GENERAL REMARKS

* Pictures on the fleet fact sheet (on separate document) are only an indication of the type of vehicle available.

* **Rates include** unlimited mileage, VAT tax, Collision Damage Waiver (CDW) with deductible.

* **Rates DO NOT include** gas, tyre repairs, police fines or penalties, accessories damaged or stolen, broken window repairs, airport tax (to be paid on the spot).

* **A collision damage bond** will be held by credit card imprint.

* **Driving Age:** minimum 21 years old. 2 drivers maximum can be declared per contract. A fee of 15 Euro will be charge for the second driver.

* **Driving Licence:** International and all valid overseas licences are accepted. Drivers must have at least 1 year of driving.

* **Pick up and Drop off:** Clients will be picked up at hotel or airport or pier and then driven to the rental car office.

On the day of Drop Off, clients will need to return the car where it was picked up. Complimentary return transfers will be provided. For Drop Off at a different place, a drop-off fee will apply. **Drop off can only be arranged during office opening hours.**

* **Fuel:** When taking the vehicle, the quantity of fuel is indicated in the contract. The client shall return the vehicle with the same quantity of fuel.

* **CANCELLATION POLICY**

Cancellation received 2 days prior to first day of rental is subject to a minimum of 1 day cancellation fee.

* **The above rates are based on 2008 VAT tax. Should these be modified in 2009, we shall reserve the right to amend our rates accordingly.**

GENERAL INSURANCE CONDITIONS

THE SCOPE OF THE COVERAGE

The rented vehicle is to be exclusively used on public or private roads normally open to car traffic. It is insured under the standard terms covering self driven vehicles and under the special terms as specified in the local insurance policy (these terms are available at the Avis office). It is forbidden to drive a rented car on dangerous roads such as the waterfall road in Tahiti or the "pineapple" road in Moorea or any other that seems dangerous by its configuration.

NOTE

In case of responsible accident or in the case of no report established with a third party, the renter will be charged for the deductible. A bill of repairing will be established for the reparation. If the amount is under the amount of deductible, the renter will be refunded for the difference.

In litigious case concerning the responsibility of each other, the insurance company will decide the responsibility rate but only if the renter and the third party have established and accepted a report.

REPORTING OF ACCIDENT

Any damage caused to the vehicle must be reported **IMMEDIATELY** (or within 24 hours). The renter must advise the rental office. Any renter who does not comply with this obligation shall be deemed responsible for the damage and consequences. The renter is also full responsible if he or she does not bring back a report signed by the third party, in case of accident. In case of litigious about responsibility, the rental office will keep the deposit until the last decision of the insurance company.

FINES

The client shall be responsible for the payment of fines if he has committed an offence against the Highway Code.

JURISDICTION

Any dispute arising from this contract shall be submitted to the competent courts of French Polynesia.

EXCLUSION OF COVERAGE

The customer shall be fully responsible for third party liability under the following circumstances, which exclude any and all guarantees:

- damages caused wilfully, with malicious intent or due to an inexcusable fault
- damages caused in particular in the event of river crossing, penetration in sea water, sinking, overturning of the vehicle, driving on road not suitable for vehicles, flat tires, burst tires or ripped tires.
- damages caused by driving under the manifest of alcohol or after the use of non-prescribed drugs or by any passenger having caused damages under such influences.
- damages caused in the event that the vehicle is stolen
- damages caused when the driving of the vehicle has been transferred to a person not designated in the rental contract.
- damages caused by keeping a car abusively by **none presentation for extending rental**.

On the island of TAHITI & MOOREA

COVERAGE

Two types of coverage are provided, along with the possibility of subscribing for an additional coverage under specific conditions at a fixed daily premium:

- Damages caused to third parties (third party liability) : the vehicle is covered against damages, which the renter may cause to third parties. It is being understood that damages to the renter himself on the rented vehicle are excluded from the guarantee. Fines, consequences of the renter's criminal liability remain at the renter's expenses.
- Damages caused to the rented vehicle, including the deductible: cover against damages to the rented vehicle following theft, broken windows, explosion, fire or accident with a deductible set on the basis of the type of vehicle under the below conditions.

CATEGORIES OF DRIVERS AND TERMS OF COVERAGE

Minimum age required is 21. The driver must have a valid driver's license issued at least one year prior to the rental day. The driver must own a credit card or provide enough financial guarantees.

* **Drivers are classified in 3 categories:**

1. **Drivers from 21 to 23 :**

Third party liability only.

2. **Drivers over 23 and under 25 with a driver's license issued between 1 and 2 years**

Third party liability with the possibility to get insurance damages including the deductible :

On the island of HUAHINE

All vehicles are under full coverage with a deductible of **50 000 XPF, tax included.**

On the island of BORA BORA

All vehicles (categories B, C & D) are under full coverage with a deductible of **200 000 XPF, tax included.**

On the island of RAIATEA

All vehicles (categories A, B & C) are under full coverage with a deductible of **155 000 XPF, tax included.**
